The undersigned also covenants and agrees with the Assignee that the undersigned has the full right to convey the interest sold and assigned and has not executed and will not execute any writing or do any act whatsoever in conflict with the rights and interest assigned; and that the undersigned will at any time upon request, without further or additional consideration, but at the expense of the Assignee: execute such additional assignments and other documents and do such additional acts as the Assignee may deem necessary or desirable to perfect or confirm this assignment and the Assignee's enjoyment of the rights acquired; and aid in enforcing any rights accruing as a result of the Patent by giving testimony in any proceedings or transactions involving the Patent and by cooperating in the execution of documents, statements, affidavits, etc. that may be required in any such proceeding or transaction.

It is understood that the foregoing covenants and agreements shall bind the legal representatives of the undersigned and inure to the benefit of the legal representatives, successors and assigns of the Assignee.
