ASSIGNMENT

Further, I hereby covenant and agree to and with Rosen Entertainment Systems, L.P., and its successors and assigns, at the time of execution and delivery of these presents, that I am the sole and lawful owner of the entire right, title, and interest in and to the invention and the above-identified design patent application, and that the same are unencumbered, and that I have good and full right and lawful authority to sell and convey the same in the manner herein set forth.


