ASSIGNOR FURTHER COVENANTS AND AGREES to execute or procure any further necessary assurance of the title to the said Patents and will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers that may be necessary or desirable to perfect the title to said Patents, and will at any time upon the request and at the expense of the Assignee testify in any legal proceeding, sign all lawful papers, execute any additional divisional, substituting, continuing or reissue applications for patents, make all rightful oaths and generally do all lawful acts to aid the Assignee, its successors, assigns or other legal representatives to obtain and enforce the Patents without further compensation but at the expense of the Assignee, its successors, assigns or other legal representatives;

AND ASSIGNOR HEREBY AUTHORIZES AND REQUESTS The Commissioner of Patents or the Comptroller (as the case may be) to issue any and all Letters Patent resulting from any division, reissue or extension of the Patents to the Assignee as sole Assignee.
