**WHEREAS**, We, the undersigned inventors, have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled Test Body, Test Arrangement, Method For Manufacturing Of A Test Body, And Method For Determining A Moisture Content Of The Insulation Of A Power Transformer During Drying Thereof, bearing U.S. Patent Application No. 12/958,034 and filed on December 1, 2010;
