

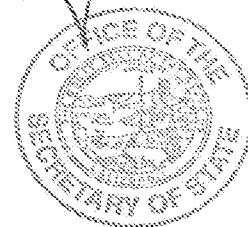
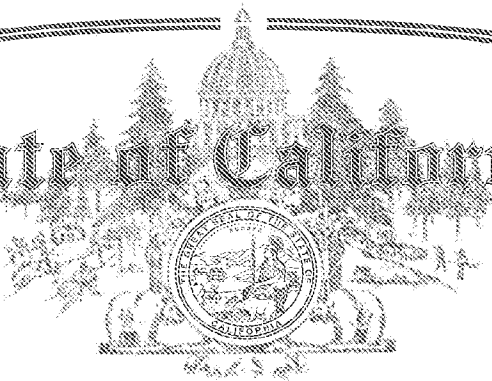

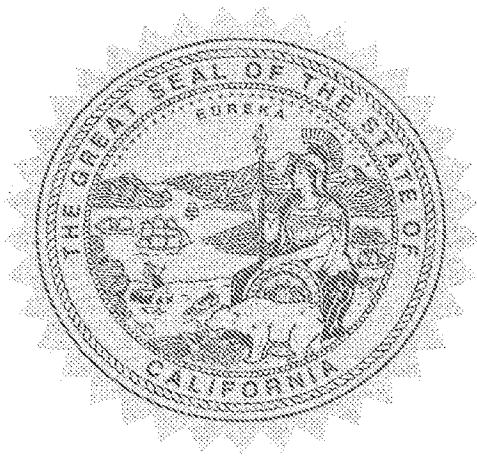

Andrew Atherton and Vladimir Gorelik hereby certify that:

1. They are the President and Secretary of Resonant Commerce Corporation, a California corporation.
2. Article I of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:


"I

The name of this corporation is Optivo Corporation."


3. The board of directors has duly approved the foregoing amendment of the Amended and Restated Articles of Incorporation.
4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the capital stock of the corporation is 3,524,658 shares of Common Stock and 4,993,436 shares of Series A Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of the outstanding stock, voting together as a single class.

The undersigned further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of their own knowledge.

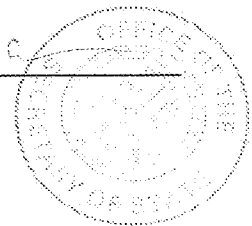
