

AND I HEREBY further covenant and agree that I will communicate to the ASSIGNEE any facts known to me respecting said Inventions, and testify in any legal proceeding, sign all lawful papers, execute all patent applications, make all rightful declarations and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for the Inventions in all countries.

And the U.S. Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents on applications as aforesaid, are hereby authorized and requested to issue Letters Patents to the ASSIGNEE in accordance with the terms of this Assignment.
