ASSIGNMENT

WHEREAS: Frank Giuffrida, an individual residing at 285 Chamberlain Road, Honeoye Falls, New York 14472; Stephen Schultz, an individual residing at 524 Bailey Road, West Henrietta, New York 14586; Robert Gray, and individual residing at 230 Bristol Street, Canandaigua, New York 14424; and Robert Bradacs, an individual residing at 2613 Titus Ave. Ext., Rochester New York 14622 (hereinafter referred to as ASSIGNORS) have invented a certain invention entitled: CUT-LINE STEERING METHODS FOR FORMING A MOSAIC IMAGE OF A GEOGRAPHICAL AREA, for which application for Letters Patent of the United States was filed on August 5, 2008, identified as U. S. Serial No. 12/221,571.




