said rights being in the United States of America and all other countries and states of the world and being to the invention or inventions related to "**PROXIMAL RELEASE DELIVERY SYSTEM**" and being described in U.S. Provisional Patent Application No. 61/291,066, filed on December 30, 2009, and any and all applications claiming the benefit thereof including the right of priority, and described in U.S. Non-Provisional Application No. 12/973,311, filed on December 20, 2010, and PCT Application No. PCT/US2010/061238 filed on December 20, 2010, and all the rights and privileges in said application and under any and all Letters Patent or any continuation, division, renewal, or substitute thereof, and any reissue or re-examination thereof that may be granted in the United States of America and in any country or state of the world for said inventions. We sell, assign, and transfer this right, title and interest as of the day of signature or of filing of the U.S. Provisional Patent Application mentioned above, whichever is the earlier.

We authorize CMT to make application for such protection in their own name and maintain such protection in any and all countries foreign to the United States, and to invoke and claim for any application for patent or other form of protection for said inventions, without further authorization from us, any and all benefits, including the right of priority provided by any and all treaties, conventions, or agreements.

We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any document which may be required in any country in proof of the right CMT to apply for patent or other form of protection for said inventions and to claim the aforesaid benefit of the right of priority.


