RELEASE OF SECURITY INTEREST AND REASSIGNMENT OF RIGHTS

This Release of Security Interest and Reassignment of Rights is made of February 9th, 2005 by COMERICA BANK, successor by merger to COMERICA BANK-CALIFORNIA, successor by merger to IMPERIAL BANK ("LENDER") to PLANETWEB, INC., successor in interest to NOVITA COMMUNICATIONS, INC. (formerly known as MAGICWEB, INC.), a California corporation, with its principal place of business at 1300 Island Drive, Suite 202, Redwood Shores, CA 94065 ("COMPANY").

Recital

WHEREAS, COMPANY assigned to LENDER certain interests in and to COMPANY's entire right, title and interest in and to certain patents and patent applications including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including, without limitation, those set forth on Exhibit A hereto (collectively, the "PATENTS") under a Collateral Assignment, Patent Mortgage and Security Agreement dated as of September 29, 1997 (the "SECURITY AGREEMENT"), which was recorded with the U.S. Patent and Trademark Office on November 25, 1997 at Reel No. 8823 and Frame No. 0119, and on March 2, 1998 at Reel No. 9016 and Frame No. 0474;

WHEREAS, LENDER wishes to release, retransfer and reassign to COMPANY all right, title and interest the LENDER may have in the PATENTS.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, LENDER hereby releases, retransfers and reassigns to COMPANY, without warranty or recourse, all right, title and interest of the LENDER in the PATENTS.
