
## ASSIGNMENT

WHEREAS, we, Giuseppe Messina, Daniele Ravi, Mirko Guarnera, and Giovanni Maria Farinella (hereinafter referred to as ASSIGNORS), having mailing addresses of Via Noto, 5, Catania, Italy 95125; Via Consolare Antica, Traversa H, n. 9, Capo d'Orlando, Messina, Italy 98071; Via Marmolada, 6, Gela, Italy 93012; and Via Ruggero Settimo, 14, Caltanissetta, Italy 93100, respectively, are the joint inventors of an invention entitled "METHOD AND APPARATUS FOR FILTERING RED AND/OR GOLDEN EYE ARTIFACTS," as described and claimed in the specification for which an application for United States letters patent was filed on December 15, 2010, and assigned Application No.12/969,252;

ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks to issue all letters patent on said invention to ASSIGNEES. 
