Andrew J. Redleaf, is an individual resident of the State of Minnesota having a place of business at 3033 Excelsior Blvd., Suite 300, c/o Whitebox Advisors, LLC, Minneapolis, Minnesota 55416 ("Redleaf"), and

Gary S. Kohler, is an individual resident of the State of Minnesota having a place of business at 3033 Excelsior Blvd., Suite 300, c/o Whitebox Advisors, LLC, Minneapolis, Minnesota 55416 ("Kohler"), and

NewCort, Cortron, Redleaf, and Kohler are collectively referred to herein as ASSIGNOR, and

ASSIGNOR owns certain inventions and improvements disclosed in the patent applications and patents (collectively, the "INTELLECTUAL PROPERTIES") listed on Exhibit A hereto, and

For the same consideration, ASSIGNOR by these presents does hereby sell, assign and transfer unto ASSIGNEE the full, exclusive and entire right, title, and interest in and to said INTELLECTUAL PROPERTIES, in and to any divisions, continuations, continuations-in-part, and reissues thereof, said divisions, continuations, continuations-in-part, and reissues being included in and part of said INTELLECTUAL PROPERTIES whether or not listed in Exhibit A, and in and to all inventions and improvements disclosed and described in said INTELLECTUAL PROPERTIES, including all rights ASSIGNOR may have to sue for damages and other remedies in respect of any infringement of the INTELLECTUAL PROPERTIES which may have occurred before the date of this ASSIGNMENT.

ASSIGNOR hereby requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States resulting from said INTELLECTUAL PROPERTIES, or from any divisional, continuation, continuation-in-part, reexamination, or reissue thereof, to ASSIGNEE, as the assignee, for its interest and for the sole use and benefit of ASSIGNEE and its assigns and legal representatives.

For the same consideration, ASSIGNOR, by these presents does hereby sell, assign, and transfer to ASSIGNEE, the full, exclusive, and entire right, title and interest in and to any and all patents and patent applications issued, filed, or which may be filed as a Patent Cooperation Treaty patent application, as any other type of international patent application, as a regional patent application, or in countries other than the United States, which correspond to any of said INTELLECTUAL PROPERTIES or claim priority of or to any of said INTELLECTUAL PROPERTIES in whole or in part (collectively, the "CORRESPONDING INTELLECTUAL PROPERTIES"), in and to any Letters Patent and similar protective rights granted on said CORRESPONDING INTELLECTUAL PROPERTIES, and in and to the right to claim any applicable priority rights arising from or required for said CORRESPONDING INTELLECTUAL PROPERTIES under the
