CONFIRMATORY PATENT ASSIGNMENT


By virtue of an IP Transfer Agreement entered into as of August 26, 2010 by and among: **Hyperion Solutions Corporation ("HSC"** - hereinafter referred to as "**Assignor**"), formerly a Delaware corporation with its place of business at 500 Oracle Parkway, Redwood Shores, California 94065; **Oracle Systems Corporation ("OSC"**), a Delaware corporation and wholly-owned subsidiary of **Oracle Corporation ("Oracle"**), a Delaware corporation, with its place of business at 500 Oracle Parkway, Redwood Shores, California 94065; **Oracle Global Holdings, Inc. ("OGH"**), a Delaware corporation and wholly-owned subsidiary of **Oracle**; and **Oracle International Corporation ("OIC"** – hereinafter referred to as "**Assignee**"), a California corporation and wholly-owned subsidiary of **Oracle**, certain steps were effected in a series of transactions for the reorganization of the domestic and international operations of **Oracle** and its subsidiaries, which transactions included: (i) the merger of **HSC** with and into **OSC**, with **OSC** as the surviving entity; and (ii) the assignment, transfer, conveyance and delivery by **HSC** to **Assignee**, its successors, legal representatives and assigns, **HSC's** entire right, title and interest in, to, and under all its inventions, patents and pending applications including the issued patents and provisional and nonprovisional patent applications listed on the attached Schedule A.

NOW THEREFORE, for the avoidance of doubt and for good and valuable consideration, **OSC**, as successor-in-interest to **HSC**, confirms the previous assignment and transfer by **HSC** to **Assignee**, and hereby does assign and transfer to **Assignee**, **HSC's** entire right, title and interest in, to, and under the issued patents and provisional and nonprovisional patent applications listed on the attached Schedule A, as well as any divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for inventions embodied by said pending applications in any country or countries foreign to the United States, and all Letters Patent which may be granted for said inventions embodied by said pending applications in any country or countries foreign to the United States and all extensions, renewals and reissues thereof and all rights of priority in any such country or countries based upon the filing of said pending applications in the United States which are created by any law, treaty or international convention, together with the right to sue for and recover damages for past infringement of any such patents.

The Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty is to issue patents on any such applications as aforesaid, is hereby authorized and requested to issue all Letters Patent for said inventions to **Assignee**, its successors, legal representatives and assigns, in accordance with the terms of these agreements.
