## ASSIGNMENT

WHEREAS, Marti Rius Rossell, Carles Flotats Vallagrass, Marcos Casaldaliga are inventors of an invention subject to United States Patent Application Serial No. 13/035986 filed 27 FEB 2011 and entitled "REGISTERING IMAGES DURING TWO-SIDED PRINTING"


