ASSIGNMENT



Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any other such country or countries whose duty it is to issue patents on applications as aforesaid, to issue all Letters Patent therefor to Assignee, Assignee's successors, legal representatives or assigns as provided by this instrument.

Assignor covenants and warrants that Assignor has the full right and power to convey the entire interest herein assigned, and that Assignor has not executed and shall not hereafter execute any document in conflict with this assignment or constituting a lien against or right under the subject matter assigned. Assignor further covenants and agrees to communicate to Assignee, Assignee's successors, legal representatives or assigns, any facts known to Assignor respecting said Invention, to testify in any proceedings, to sign all lawful papers, and to execute all applications for patent and other documents and generally to do everything possible to aid Assignee, Assignee's successors, legal representatives or assigns to obtain and enforce any and all Letters Patent for said Invention in all countries.
