- (a) the APPLICATIONS AND PATENTS, any parent patent applications, and all patent applications, patents and supplementary protection certificates which may derive or result from any of the same, including any divisionals, continuations, reissues, extensions and registrations in relation to any thereof and all and any other rights in the inventions comprised in any of the above (together referred to as the "PATENT RIGHTS");
- (b) the benefit of all priority dates;
- (c) the right to seek and obtain registrations in other countries;
- (d) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past present or future) of any of the PATENT RIGHTS or of the rights conferred by publication of any of the same.

2. Authorisation

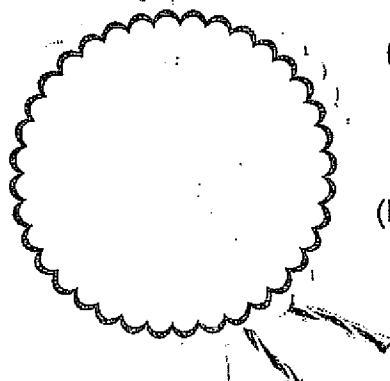
