ASSIGNMENT

WHEREAS, WE, Thomas J. Quigley and Ted Rabenko, residing at Franklin, North Carolina 28734 and Duluth, Georgia 30097, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **METHOD AND APPARATUS FOR LATENCY REDUCTION IN LOW POWER TWO WAY COMMUNICATIONS EQUIPMENT APPLICATIONS IN HYBRID FIBER COAX PLANTS**, filed August 31, 2000, Application No. 09/654,109.


AND WE HEREBY covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;


