**ASSIGNMENT OF MEMBERSHIP INTEREST

TO HAVE AND TO HOLD the Membership Interest unto the Assignee, its successors and assigns forever. The Assignor does bind itself, its successors and assigns to WARRANT and FOREVER DEFEND all and singular the Membership Interest unto the Assignee and the Assignee’s successors and assigns against any person whomsoever lawfully claiming or to claim the same or any part thereof.

The Assignor represents and warrants to the Assignee that (i) the Assignor is the sole owner of the Membership Interest and has the unencumbered right to enter into this Agreement and to convey the Membership Interest, (ii) that the transfer is made in accordance with applicable law and (iii) that the Assignor will take any and all other actions requested by the Assignee to effectuate the conveyance contained herein.

This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which taken together shall constitute one and the same document.
