Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and similar officers of foreign countries to issue patents, other evidence, and forms of intellectual property protection or applications to Assignee and its successors and assigns in accordance with the terms of this Patent Assignment Agreement.
