THIS DEED OF ASSIGNMENT is made the 14th day of July , 2009

(2) JAtech Industrial, Inc., a company incorporated in the State of California in the United States of America with registered office at 1550 Atlantic Street, Union City CA94587, U.S.A.

("the Assignor");

(3) JAtech Precision (H.K.) Limited, a company incorporated in Hong Kong with registered office at Units 8-9, 4th Floor, Vanta Ind. Centre, 21-33 Tai Lin Pai Road, Kwai Chung, New Territories, Hong Kong

("the Assignee").

WHEREAS :-

The Applicant was the applicant for the Patent and had assigned the Patent Application to the Assignor, and both the Applicant and the Assignor have agreed to assign the Patent Application to the Assignee such that the Assignee should be substituted as applicant for the Patent.

**THIS DEED OF ASSIGNMENT WITNESSES** as follows :

**1. Definitions**

The following terms shall have the following meanings :

“Invention”                      the invention[s] claimed in the Patent;

“Patent”                              the prospective patent for which the Patent Application has been made;

“Patent Application”      The Patent Application Number 12115467 filed with the United States Patent And Trademark Office.

**2. Assignment**

Pursuant to the said agreement and for consideration received, the Assignor assigns to the Assignee absolutely and free from all incumbrances the Patent Application together with all the Assignor's rights and interests in respect of it.

**3. Applicant and Assignor's obligations**

The Applicant and the Assignor jointly and severally undertakes with the Assignee :

(a) Further assurances

To execute such documents and give such assistance as the Assignee may require :

- (i) to secure the vesting in the Assignee of all rights in the Patent Application;
  - (ii) to uphold the Assignee's rights in the Patent Application;
  - (iii) to defeat any challenge to the validity of, and resolve any questions concerning, the Patent Application;
  - (iv) to apply for and endeavour to assist the obtaining of other patents or other similar protection for the Invention and any improvements of it in the United States or other parts of the world; and
  - (v) to do all that is necessary to vest such protection in the Assignee absolutely;
- (b) Supply of information
- (i) to inform the Assignee of all technical information concerning the Invention;
  - (ii) to supply the Assignee with any documents or drawings relevant to the Invention; and
  - (iii) to license the Assignee to use such documents information and drawings.
- (c) Improvements

If an improvement to the Invention is discovered

- (i) to disclose to the Assignee full details of the improvement;  
and
- (ii) to grant to the Assignee an exclusive royalty-free licence to  
make use of it.

**4. Applicant and Assignor's warranties and indemnity**

The Applicant and the Assignor jointly and severally warrants, represents and undertakes that :

- (a) the Applicant is the sole applicant of the Patent Application and had assigned the Patent Application and all his rights and interest therein or in respect thereof to the Assignor, and both the Applicant and the Assignor has full power to enter into this Assignment;
- (b) the Patent Application is still subsisting;
- (c) Either the Applicant or the Assignor has not granted any Licences to use the Invention within the United State nor suffered the Patent Application to be the subject of any charge mortgage or other incumbrances;
- (d) Either the Applicant or the Assignor has not done or omitted to do and is not aware of any act that will prevent the Patent from being granted;
- (e) the Applicant and the Assignor will keep the Assignee fully

indemnified against all actions claims proceedings costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisors to compromise or settle any claim) and all legal costs or other expenses arising out of any breach of the above warranties or out of any claim by a third party.

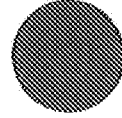

### 5.2 Proper law and jurisdiction

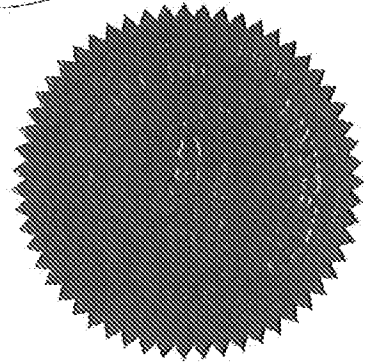


