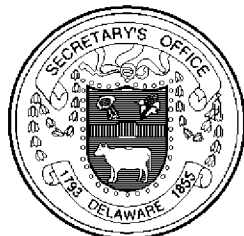

"FIRST: The name of the corporation is: Excelitas Technologies Sensors, Inc."


