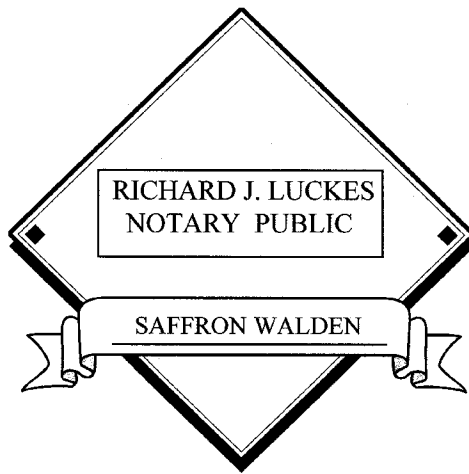

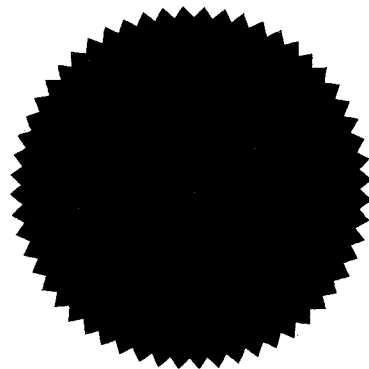

(1) **Plextek Limited**, a company incorporated and registered in England with company number 02305889 whose registered office is at Plextek Building, London Road, Great Chesterford, Essex, CB10 1NY, England (**Plextek**); and

(2) **Telensa Limited**, a company incorporated and registered in England with company number 04498125 whose registered office is at Plextek Building, London Road, Great Chesterford, Saffron Walden, Essex, CB10 1NY, England (**Telensa**).

together "the parties", and each a "party".

BACKGROUND

On 26th November 2010, the parties entered into an Intellectual Property Rights Licence by Deed in which **Plextek** granted to **Telensa** an exclusive royalty-free licence to use of Intellectual Property Rights subject to certain terms. The parties wish to record the licence against the registered Intellectual Property Rights of **Plextek** in the **United States of America**

AGREED TERMS**1. INTERPRETATION****1.1** The definitions in this clause apply:

Effective Date: 26th November 2010: the date of the Intellectual Property Rights Licence by Deed.

Intellectual Property Rights: means any patents, rights to inventions, copyright and related rights, trade marks, trade names, domain names, rights in get-up, rights in goodwill and/or to sue for passing off, unfair competition rights, rights in designs, rights in computer software, database rights, know how, trade secrets, and any other intellectual property rights, whether registered or unregistered, and including all applications (and rights to apply) for, and renewals or extensions of, such rights and all similar or equivalent rights or forms of protection.

Patents: the patents and patent applications, short particulars of which are set out in Schedule 1 and granted patents issuing from such applications and any patents and patent applications that may be notified in writing by **Plextek** to **Telensa** from time to time.

2. LICENCE

2.1 **Plextek** hereby confirms that it has granted to **Telensa** an exclusive royalty-free licence under the Intellectual Property Rights listed in Schedule 1 to use, improve, enhance, change or modify said Intellectual Property Rights for internal business purposes and to commercially exploit said Intellectual Property Rights in the **United States of America**

- 2.2 Telensa shall have the right to grant to any person a sub-licence under its rights under clause 2.1 above subject to the terms of the Intellectual Property Rights Licence by Deed of 26th November 2010.

3. DURATION AND TERMINATION

- 3.1 The Intellectual Property Rights Licence by Deed came into effect on 26th November 2010 and, unless terminated earlier in accordance with the terms of that Agreement, shall remain in force until the expiry of all the Intellectual Property Rights.
