**ASSIGNMENT**

**SELL, ASSIGN AND TRANSFER** to ZAGG Incorporated, a corporation of the State of Nevada, having a place of business at 3855 South 500 West, Suite J, Salt Lake City, Utah 84115, the entire right, title and interest in and to any and all improvements that are disclosed in the Application for United States Design Patent No. 29/379,839, titled "SUPPORT ELEMENT OF A PROTECTIVE COVER FOR A MOBILE COMPUTING DEVICE," filed on November 24, 2011, such application and all continuing, divisional, reissue, substitute, renewal and all other applications for patent or the legal equivalent thereto that have been or may be filed in the United States and all foreign countries relating to any of such improvements; all original reexamined and reissued patents that have been or shall be issued in the United States and all foreign countries on such improvements; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application made in the United States;

**COVENANT**, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment, to execute all continuing, divisional, reissue, substitute, renewal and all other applications for patent or legal equivalent thereto relating to any and all such improvements; to execute all rightful oaths, declarations, assignments, powers of attorney and other papers; to communicate to the ASSIGNEE all facts and to provide to the ASSIGNEE all documents and things known and accessible to the undersigned relating to such improvements and the history thereof, and testify as to the same in any interference, litigation or other proceeding relating thereto; and generally do everything possible that the ASSIGNEE shall consider desirable for vesting title to such improvements in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable protection for such improvements;
