PATENT ASSIGNMENT

WHEREAS, Holiday Properties Acquisition Corp., an Ohio corporation ("Assignor"), is the exclusive owner of U.S. Patent No. 5,053,584 (the "Patent");

This agreement shall be binding upon and shall inure to the benefit of the respective successors and permitted assigns of Assignor and Assignee.
