ASSIGNMENT

WHEREAS, we, Todd P. Beach, of San Diego, California, Joseph Henry Hoffman, of Carlsbad, California, Scott Taylor, of Bonita, California, and Sang S. Yi, of San Marcos, California, have invented a certain invention as described in the following patent application:

We confirm that at the time the invention was made, we were under an obligation to assign the invention to Taylor Made Golf Company, Inc.






