ASSIGNMENT

WHEREAS, We, Sebastian Heger of Spitalwall 2, 91438 Bad Windsheim, Germany and Werner Lang, Mühlleite 65, 91465 Ergersheim, Germany, have invented certain new and useful improvements in a Adapter For Precise And Accurate Attachment Of A Mirror Unit To A Support Arm for which a United States Patent Application Number 13/009,921 was filed January 01, 2011; said patent application and the invention described therein being hereafter referred to as the "Patent Rights";

WHEREAS, Lang-Mekra North America, LLC., a South Carolina limited liability company, having a place of business at 101 Tillessen Boulevard, Ridgeway, SC 29130 is desirous of acquiring 1% of the entire right, title and interest in and to said Patent Rights, and in and to any Letters Patent that may be granted therefor in the United States and in any and all foreign countries in North, Central and South America;

KG., a German Corporation, having a place of business at Buchheimer Str. 4, D-91465 Ergersheim, Germany, is desirous of acquiring 99% of the entire right, title and interest in and to said Patent Rights, and in and to any Letters Patent that may be granted therefor in the United States and in any and all foreign countries in North, Central and South America;

NOW THEREFORE, for good and valuable consideration given to us in hand paid, the receipt and sufficiency of which is hereby acknowledged, and other good and valuable consideration, I, the aforesaid have sold, assigned and transferred, and by these presents do sell, assign and transfer unto said Lang-Mekra North America, LLC, its successors and assigns, and unto said Mekra Lang GmbH & Co. KG., its successors and assigns, respectively in the percentages above, the full and exclusive right to the said invention in the United States and its territorial possessions, and in all foreign countries in North, Central and South America, and the entire right, title and interest to the Patent Rights and interest in and to any and all Letters Patent of the United States and its territorial possessions, and in any and all foreign countries in North, Central and South America to be obtained therefor on said invention or any continuation, division, renewal, substitute or reissue, or reexamination thereof for the full term for which the same may be granted.


We hereby authorize and request the Patent Office to assign 1% of the above identified Patent Application to Lang-Mekra North America, LLC, and to assign 99% of the above identified Patent Application to Mekra Lang GmbH & Co. KG. as the assignees of our entire right, title and interest in and to the same.

Further, We will communicate to Lang-Mekra North America, LLC and Mekra Lang GmbH & Co. KG. any facts known to us respecting said invention, and testify in any legal proceedings, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid said assignees, their successors and assigns, to obtain and enforce proper protection for said inventions and Patent Rights and Letters Patent in the United States, and in any and all foreign countries in North, Central and South America.


The Parties hereto agree that Lang-Mekra North America, LLC shall not be permitted to sell, mortgage or otherwise dispose of its co-ownership shares to third-parties.

This assignment as well as the transfer of the co-ownership shares from Lang-Mekra North America, LLC to third parties will automatically become ineffective as part of the resolute condition should these be sold, mortgaged or otherwise disposed of.
