- C. The Assignor wishes to record, and the Assignee wishes to accept the assignment to the Assignee of all of the Assignor's right, title and interest in and to the Patent Rights, on the terms set out in this Assignment.
- D. The Assignor indicates to the Assignee that regarding the Irish Patent number 83276 and the United States Patent US 6,636,493 B2 there is existing a License Agreement with WAL SIN TECHNOLOGY CORPORATION and that the Assignor will give notice of this Assignment to Walsin Technology Corporation.

**1 ASSIGNMENT**

In consideration for the payment of €1 (euro) by the Assignee to the Assignor (the receipt and sufficiency of which is hereby acknowledged) the Assignor does hereby assign to the Assignee, its successors and assigns, all of the Assignor's right, title and interest in and to the Patent Rights, together with all the rights of action, powers, and benefits belonging to same, including all treaty, convention, statutory and common law rights (including priority rights) and the right to sue for and obtain damages and other relief in respect of any infringement (whether past, present or future) of the Patent Rights or any of them and for the Assignee, its successors and assigns to hold, use, exercise and enjoy same unto the Assignee absolutely for the whole period of such rights for the time being capable of being assigned by the Assignor, together with any and all renewals and extensions throughout the world; and the Assignee hereby accepts all the foregoing.

**2 COUNTERPARTS**

This Agreement may be executed in more than one counterpart, each of which shall be deemed to and shall come into force once both the Assignor and Assignee have executed and delivered such a counterpart in identical form.

**3 GOVERNING LAW**

This Assignment shall be subject to the laws of Ireland and the parties submit to the exclusive jurisdiction of the courts of Ireland.

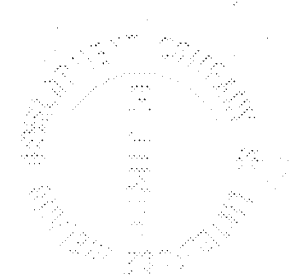
