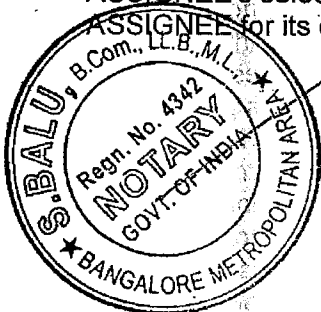
ASSIGNMENT

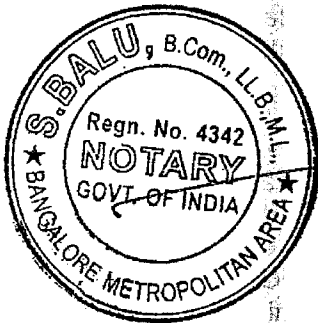

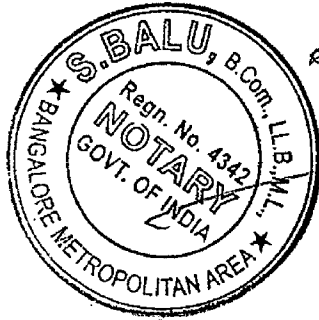

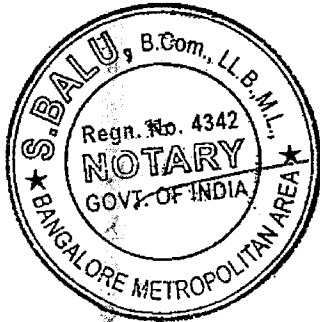
