


ASSIGNMENT AGREEMENT





2. **Transferor** has assigned to **Transferee** all rights relating to the licensing business of **Transferor** and **Transferee** has accepted all rights and liabilities related to the licensing business of **Transferor**.
3. **Transferor** has assigned to **Transferee** the entire right, title and interest in and to all intellectual property rights owned by **Transferor**, including, but not limited to, trademarks, patents, designs and copyrights, and **Transferee** has accepted from **Transferor** the entire right, title and interest in and to all intellectual property rights owned by **Transferor**, including, but not limited to, trademarks, patents, designs and copyrights.
4. The Assignment Agreement is effective from 15 December 2002.
5. The Assignment Agreement is governed by Dutch law.
