## CONFIRMATORY ASSIGNMENT

Whereas Dilip S, Hendrik Santo, Tushar Dhayagude, Kien Vi, Sean Chen, c/o mSilica Incorporated, 3300 Central Expressway, Santa Clara, California 95051 (hereinafter "the INVENTORS") made the invention(s) and improvement(s) described in United States patent application serial number 12018399 filed on January 23, 2008 entitled System and Method for Backlight Control for an Electronic Display (hereinafter "the Invention");

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and by virtue of the terms of their employment/engagement agreements with MSILICA, the INVENTORS hereby confirm their Prior Assignment to MSILICA, and, to the extent that may be necessary to achieve the purpose of the Prior Assignment, hereby sell, assign, and transfer, and have sold, assigned, and transferred, their entire right, title, and interest throughout the world in the Invention to MSILICA, its successors, and assigns, including all right, title, and interest throughout the world that presently exists or that may arise in the future, including, but not limited to, the right to claim priority; all divisionals, continuations, continuations-in-part, or renewals thereof; all patents, utility models, designs, inventor's certificates, or registrations that may be granted therefrom, including all reissues, reexamination certificates, or extensions of such patents; all related applications which have been or shall be filed in any country; and all rights, powers, privileges, and immunities arising from the Invention, together with all right, title, and interest throughout the world in all causes of action, either in law or equity, for infringement thereof, including all rights of action and damages for past infringement.

AND the INVENTORS hereby covenant and agree that they will, at the expense of MSILICA, its successors, and assigns, execute all documents and do all such acts and things as MSILICA, its successors, and assigns may in its/their absolute discretion consider necessary or desirable to enable Letters Patent or any form of protection to be issued in respect of the Invention in any part or parts of the world and to vest the same in the name of MSILICA, its successors, and assigns free from all encumbrances, and to

enable or to assist MSILICA, its successors, and assigns to defend oppositions to grant thereof, to maintain the same when granted and to present and prosecute for the infringement thereof.
