## **ASSIGNMENT**

1. I, Terral A. Ridgell of 17625 J.E. Joiner Road, Tickfaw, Louisiana 70466, U.S.A., have made a certain new and useful invention relating to

### **CONVEYOR BELT AND MODULE WITH HOOKED CONNECTION AND ASSOCIATED METHOD**
