WHEREAS, we, Matthias Ulrich, residing at Am hohlen Wege 2, 37124 Rosdorf, Germany, Arnold Sonntag, residing at Burgstrasse 6, 37073 Göttingen, Germany, and Thomas Thöniss, residing at An der Feldscheide 2, 37083 Göttingen, Germany, have invented new and useful improvements in METHOD FOR PRODUCING AN OBJECTIVE for which we have made application for Letters Patent of the United States, said application having been filed on the 18th day of February 2011 and having a U.S. Serial No. 13/020,414; and

We hereby authorize and request the Patent Office officials in the United States and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said Qioptiq Photonics GmbH & Co. KG as the assignee of our entire right, title and interest in and to the same, for the sole use and behoof of said Qioptiq Photonics GmbH & Co. KG its successors and assigns.

KG, make all rightful oaths and generally to do everything possible to aid said Qioptiq Photonics GmbH & Co. KG, its

successors and assigns, to obtain and enforce protection for said invention in the United States and in any and all foreign countries.
