TECHNOLOGY ASSIGNMENT AGREEMENT - LIGHTING

This Technology Assignment Agreement – Lighting (this "<u>Assignment</u>") is made and entered into as of December 23, 2010 (the "<u>Effective Date</u>"), by and among BRIAN E. RICHARDSON, an individual ("<u>Mr. Richardson</u>") and EILEEN H. RICHARDSON, an individual ("<u>Mrs. Richardson</u>") (collectively, Mr. Richardson and Mrs. Richardson the "<u>Assignors</u>"), IMAGINE ILLUMINATION, LLC, a Delaware limited liability company (the "<u>Company</u>") and IMAGINE DESIGNS, INC., a California corporation, ("<u>Imagine Designs</u>").

WITNESSETH

WHEREAS, Assignors are the exclusive owners of certain Lighting and Display Technology (as defined below) and all Technical IP Rights (as defined below) therein;

WHEREAS, Mr. Richardson has granted a license to Imagine Designs with respect to such Lighting and Display Technology pursuant to the Technology License Agreement – Lighting dated November 12, 2010, between Mr. Richardson and Imagine Designs (the "License Agreement"); and

WHEREAS, Assignors and Company have entered into that certain Settlement, Waiver and Release Agreement dated November 12, 2010 (the "Settlement Agreement") in which Assignors have expressed the intention to assign the Lighting and Display Technology and all Technical IP Rights therein to Company and certain third parties have provided a release of claims in reliance on said expression;

WHEREAS, in connection with Assignors' obligations under the Settlement Agreement, Assignors desire to assign to Company (i) Assignors' entire and exclusive right, title and interest in and to the Lighting and Display Technology and all Technical IP Rights therein, and (ii) all rights of Mr. Richardson under the License Agreement.

Now, THEREFORE, it is agreed as follows:

1. **DEFINITIONS**

- 1.1. "Copyrights" means copyrights (whether or not registered), and all other rights corresponding thereto in any works of authorship (including Software and firmware) throughout the world, including moral and economic rights of authors and inventors, however denominated and regardless of medium of fixation or means of expression.
- **1.2.** "Encumbrance" means one or more liens, mortgages, pledges, security interests, prior assignments or any other restrictions on the sale, transfer, conveyance, or exploitation of any of the Transferred IP.
- 1.3. "Governmental or Regulatory Body" means any court, tribunal, arbitrator or any government or quasi-governmental entity or municipality or political or other subdivision thereof, whether federal, state, city, county, local, provincial, foreign or multinational, or any agency, department, board, authority, bureau, branch, commission, official or instrumentality of any of the foregoing, including without

- limitation, the United States Patent and Trademark Office (the "PTO") or equivalent authority anywhere in the world
- 1.4. "<u>Intellectual Property</u>" means, collectively, Technology, Trademarks and Technical IP Rights.
- **1.5.** "Law" means any law, statute, rule, regulation, ordinance, directive, decree, codes, awards, Orders, and other pronouncement having the effect of law of any country or state, or of any Governmental or Regulatory Body.
- 1.6. "Lighting and Display Technology" means (a) Technology relating to any illumination, lighting or display application, (b) Technology embodied in any product or service (including, without limitation, any prototypes or finished products) incorporating or developed with reference to the inventions and discoveries in the Transferred Patent Assets, and (c) Technology embodied in any product or service (including, without limitation, any prototypes or finished products) incorporating or developed with reference to the inventions and discoveries in the Listed Transferred Assets.
- 1.7. "Listed Other IP Assets" means those Copyrights and Trademarks listed or described on Schedule II.
- 1.8. "Listed Patent Assets" means those Patents and Patent Applications listed or described on Schedule III.
- 1.9. "Listed Technology Assets" means the Technology listed or described in Schedule IV.
- 1.10. "<u>Listed Transferred Assets</u>" means, collectively, the Listed Patent Assets, the Listed Technology Assets, and the Listed Other IP Assets.
- 1.11. "Mask Work Rights" means rights in mask works and registrations and applications for registration or renewal thereof.
- 1.12. "<u>Order</u>" means any writ, judgment, decree, award, ruling, injunction or similar order of any Governmental or Regulatory Body, in each case whether preliminary or final.
- **1.13.** "<u>Patent</u>' means any granted patent, certificate of invention, registration, or utility or industrial design regardless of jurisdiction.
- **1.14.** "Patent Application" means any application for a patent, certificate of invention, registration, or utility or industrial design including divisionals, provisionals, substitutions, continuations, continuations-in-part, and re-examinations regardless of jurisdiction.
- 1.15. "Patent Related Materials" means any and all files, documents and materials (whether in electronic or tangible format) that: (a) constitute, comprise or relate to the investigation, evaluation, preparation, prosecution, maintenance, defense, enforcement,

filing, issuance or registration of any of the Transferred Patent Assets or any abandoned application or expired provisional application in the same patent family as any of the Transferred Patent Assets or claiming priority from or having priority claims to any of the Transferred Patent Assets; or (b) help to support or establish the dates of conception or reduction to practice of any inventions, including, but not limited to, laboratory reports, invention disclosures and inventor notebooks, and those portions of the laboratory and inventor notebooks containing such information.

- **1.16.** "Person" means any individual, corporation, partnership, limited liability company, firm, joint venture, association, company, trust, unincorporated organization, Governmental or Regulatory Body or other entity.
- **1.17.** "<u>Technical IP Rights</u>" mean any or all common law or statutory rights in any of the following: Patents, Patent Applications, Copyrights, Mask Work Rights, and Trade Secrets. Technical IP Rights shall not include Trademarks.
- 1.18. "Technology" means any or all of the following instantiations or embodiments of the following in any form and embodied in any media: (i) works of authorship including computer programs, source code, and object code, whether embodied in Software, firmware or otherwise, architecture, documentation, designs, files, records and data, (ii) inventions (whether or not patentable), discoveries, improvements, invention disclosures, inventor notebooks, records, research and documentation related to inventions, (iii) proprietary and confidential information, show-how and know how, (iv) databases, data compilations and collections, (v) technical data, customer lists, supplier lists, component lists, manufacturing process or procedures descriptions, manuals, schedules, prototypes, methods and processes, and (vi) technology, hardware, tools, manufacturing equipment, molds, casts, masters, templates, or machinery.
- 1.19. "Trade Secrets" means all trade secrets (including those trade secrets defined in the Uniform Trade Secrets Act and under corresponding foreign statutory and common law) for all business, technical and know-how information, show-how information, non-public information, and confidential information and rights to limit the use or disclosure thereof by any Person including databases and data collections and all rights therein.
- 1.20. "<u>Trademarks</u>" means any and all trade names, logos, trade dress, slogans, common law trademarks and service marks, trademark and service mark registrations and applications therefor and all goodwill associated therewith and any similar or equivalent rights to any of the foregoing (as applicable) whether now known or hereafter recognized in any jurisdiction worldwide, arising out of, or associated with the foregoing.
- 1.21. "Transferred IP" means, collectively, any and all (a) Transferred Patent Assets, (b) Transferred Technology, (c) Listed Other IP Assets, and (d) any other Intellectual Property and Technology specifically identified herein as being acquired by Company.

- 1.22. "Transferred Patent Assets" means: (a) the Listed Patent Assets; (b) any and all other Patents and Patent Applications that claim priority from any of the Listed Patent Assets, including, without limitation any and all reexaminations, extensions, reissues, divisionals, renewals, provisionals, substitutions, continuations and continuations-in-part, and foreign Patents and Patent Applications; (c) any and all other Patents and Patent Applications set forth under subsections (a) and (b) above; and (d) any and all inventions and discoveries in the Patents and Patent Applications set forth under subsections (a), (b) and (c) above.
- 1.23. "<u>Transferred Technology</u>" means the Lighting and Display Technology of Assignors, including, without limitation, the Listed Technology Assets.

2. ASSIGNMENT

- 2.1. Assignment of Purchased Assets. Subject to the terms and conditions set forth in this Agreement, Assignors hereby agree to irrevocably sell, convey, transfer and assign, and hereby do irrevocably sell, convey, transfer and assign, to Company, free and clear of all Encumbrances, and Company hereby agrees to and does hereby purchase from Assignors, all right, title and interest in and to the following assets (collectively, the "Purchased Assets"):
 - (a) the Transferred IP;
 - (b) the Patent Related Materials;
 - (c) all rights of Mr. Richardson under the License Agreement;
 - (d) all other goodwill related to the assets described in Sections 2.1(a) through 2.1(c) above; and
 - (e) all rights, claims and privileges pertaining to, arising out of, or associated with, the assets described in Sections 2.1(a) through 2.1(d) above, including, without limitation, the right to license the Transferred IP, the right to file, prosecute and maintain the Transferred IP, the right to collect royalties or other payments, and the right to initiate causes of action for injunctive relief and other remedies of any kind for all past, present and future infringement or misappropriation of any Technical IP Rights stemming from the Transferred IP.
 - **2.2. Delivery by Assignors.** On or prior to the Effective Date, Assignors shall execute, or have previously executed, and deliver to Company:
 - (a) All of the Purchased Assets or, in the case of the Transferred IP or other intangible assets, such instruments as are necessary or desirable to document and to transfer title to such assets from Assignors to Company;

- (b) Fully executed and notarized forms of patent assignment for the Patents and Patent Applications within the Purchased Assets in the forms attached hereto as Exhibit A-1 (the U.S. Patents), Exhibit A-2 (the GB patents), Exhibit A-3 (the JP patents), Exhibit A-4 (the DE patents), Exhibit A-5 (the EP patents), Exhibit A-6 (the FR patents), and Exhibit A-7 (the Applications assignment). The parties agree that execution of such patent assignment(s) is done solely for confirmation, and is not necessary to effect the assignment contemplated by this Agreement;
- (c) A fully executed and notarized form of copyright assignment for each of the Copyrights within the Purchased Assets in the form attached hereto as Exhibit B. The parties agree that execution of such patent assignment(s) is done solely for confirmation, and is not necessary to effect the assignment contemplated by this Agreement;
- (d) Such other good and sufficient instruments of conveyance, assignment and transfer, in form and substance reasonably acceptable to Company, as shall be effective to vest in Company good and valid title in and to the Purchased Assets;
- (e) The License Agreement; and
- (f) All documents comprising Transferred Technology.

2.3. Taking of Necessary Action; Further Action.

- (a) If at any time after the Effective Date, any further action is necessary or desirable to carry out the purposes of this Agreement and to vest Company with full right, title and possession to all Purchased Assets, Company (and its officers and directors) and Assignors are fully authorized to take, and will take, all such necessary or desirable action in accordance with all applicable Laws including executing and delivering such other agreements and instruments as may be necessary or desirable in connection with the foregoing.
- (b) From time to time after the Effective Date, Assignors shall execute and deliver such other instruments of transfer and documents related thereto and take such other action as Company may reasonably request in order to effect the transactions contemplated by this Agreement and effectively transfer to Company, and to place Company in possession and control of, the Purchased Assets (including all copies thereof), and to enable Company to exercise and enjoy all rights and benefits with respect thereto.
- (c) There may exist Transferred IP that, contrary to the intent of this Agreement and the agreements entered into in connection with this Agreement, that existed as of the Effective Date and is discovered to have been inadvertently retained by Assignors. Assignors and Company shall cooperate in good faith to promptly effect the transfer of such Transferred IP, to or by the appropriate

party and shall not use the determination that remedial actions need to be taken to alter the original intent of Assignors and Company with respect to the Transferred IP to be transferred to Company. Without limiting the foregoing, Assignors further agree to perform all such lawful acts and to execute all such further assignments and other lawful documents as may reasonably be necessary to effectuate the assignment of, and to perfect and record the assignment of, the Transferred IP to Company in the various jurisdictions and permit for the orderly transition of the prosecution and maintenance of such Transferred IP from Assignors to Company. Such assistance shall include, without limitation, Assignors providing: (a) a list of contact information for all third parties responsible for prosecuting and maintaining the Transferred IP ("Counsel"); (b) a letter to all such Counsel informing them of the change of ownership of the Transferred IP from Assignors to Company including language reasonably acceptable to Company informing and instructing such Counsel (i) to cooperate with Company, (ii) that it is Company's desire to continue prosecution uninterrupted with the assistance of such Counsel and that Assignors do not object to such Counsel's representation of Company with respect to prosecution of the Transferred IP, and (iii) that all further actions with respect to the Transferred IP following Closing will be at the expense of Company; (c) powers of attorney and powers to inspect or copy in forms reasonably acceptable to Company with respect to priority documents relating to items of Transferred IP identified by Company; and (d) the re-execution of assignments in a form reasonably acceptable to Company for those items of Transferred IP identified by Company, as required by local law and practice.

2.4. Power of Attorney. Assignors hereby irrevocably appoint Company as their attorney in fact to undertake all acts legal and desirable by Company to evidence, effect, and record Assignors' sale, assignment, transfer and conveyance to Company of, and to perfect Company's interest in, all right, title and interest in and to the Transferred Patent Assets as described under Section 2.1 above. The foregoing appointment of Company as Assignors' attorney in fact shall be deemed to be coupled with an interest of Company in the Transferred Patent Assets.

3. REPRESENTATIONS AND WARRANTIES.

Assignors hereby represent and warrant that:

3.1. Assignor is the sole owners of all right, title and interest in and to the Transferred IP and has good and marketable title to the Transferred IP free and clear of all liens, claims and encumbrances. No other person or entity has any rights or interest in the Transferred IP. Assignor has full legal right, power and authority to sell, assign and transfer the Transferred IP as provided herein, provided, however, that the foregoing shall not be interpreted as a representation of non-infringement of unknown third party rights. Assignor has not granted or purported to grant any licenses or other interests in, under or relating to the Transferred IP, other than the licenses granted in the License Agreement and the licenses listed in **Exhibit A** thereunder. Assignor has not executed and will not execute any agreement in conflict with this Assignment.

3.2. Authority. This Agreement has been duly executed and delivered by or on behalf of Assignors. This Agreement constitutes the legal, valid and binding obligation of Assignors, enforceable against Assignors in accordance with its terms.

4. Consent to Assignment.

Imagine Designs hereby expressly consents to the assignment of all of Assignors' rights under the License Agreement to Company.

5. MISCELLANEOUS

- 5.1. No Conditions to Effectiveness; Entire Assignment. There are no conditions to the effectiveness of this Assignment. This Assignment contains the entire agreement and understanding of the parties hereto, and supersedes any prior agreements or understandings between or among the parties hereto, with respect to the subject matter hereof.
- **5.2.** Governing Law. This Assignment, and the rights of the parties hereto, shall be governed by and construed in accordance with the laws of the State of California as such laws apply to agreements among California residents made and to be performed entirely within the State of California.
- 5.3. Amendment and Waivers. This Assignment may be amended only by an instrument in writing signed by the parties hereto. No waivers of or exceptions to any term, condition or provision of this Assignment, in any one or more instances, shall be deemed to be, or construed as, a further or continuing waiver of any such term, condition or provision.
- **5.4.** Severability. If any provision of this Assignment is held to be invalid or unenforceable, the validity and enforceability of the remaining provisions of this Assignment shall not be affected thereby.
- 5.5. Successors and Assigns. This Assignment shall inure to the benefit of and be binding upon the parties hereto and their respective heirs, successors, assigns, administrators, executors and other legal representatives.
- **5.6.** Counterparts. This Assignment may be executed in one or more counterparts, each of which will be deemed an original but all of which together shall constitute one and the same agreement.
- 5.7. Attorney's Fees. In the event that any suit or action is instituted to enforce any provision in this Assignment, the prevailing party shall be entitled to all costs and expenses of maintaining such suit or action, including reasonable attorneys' fees.


