## ASSIGNMENT

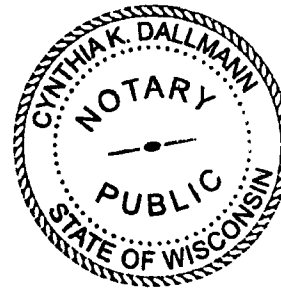

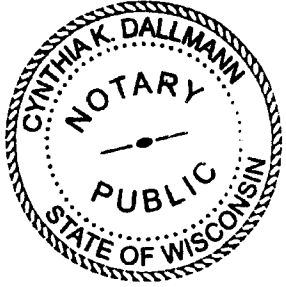
