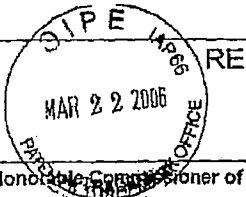

ASSIGNMENT

WHEREAS we the inventors and Assignors, Henri August Primo and Jurgen Muller, respectively have made (a) certain new and useful invention(s) as set forth in an application for United States Letters Patent entitled "APPARATUS FOR PROCESSING AND DIGITIZING PHOTOGRAPHIC FILM IN ONE PASS" which was filed on December 11, 1992 as application no. 07/989,364, a continuation to which was filed by the same inventors on January 23, 1995 as application no. 08/376,441, a further continuation to which was filed by the same inventors on December 28, 1995 as application no. 08/580,389, said application being granted January 30, 2001 as U.S. Patent no. 6,181,809;

NOW THEREFORE for good and valuable considerations, hereby acknowledged by the Assignors, we do each of us under this Assignment Nunc Pro Tunc hereby sell, assign, transfer and set over unto Agfa-Gevaert N.V., its legal representatives, successors, and assigns, the entire right, title and interest in and to all inventions whether joint or sole disclosed in said applications and patent and in and to any and all divisional, continuation or reissue applications that may be filed for United States Letters Patent for any of said inventions and in and to any and all applications and patents for any foreign country (i.e. other than the United States) that may be filed for said invention(s) with the right to claim the priority under the Paris Convention of said United States applications for Letter Patents and in and to any and all United States and foreign Patents that may be granted on the foregoing applications, whereby the effective date of this Assignment Nunc Pro Tunc is July 31, 2000;

UPON SAID CONSIDERATIONS, we do hereby agree with Assignee that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will, at any time upon request, without further or additional consideration but at the expense of the said Assignee, execute such additional assignments and other writings and do such additional acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuation or reissued Letters Patent of the United States and in making application for and obtaining Letters Patent of any foreign country on said invention(s) as referred to herein before, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind the Assignor(s) and the Assignee(s);

And we request the Commissioner of Patents to issue any Letters Patent of the United States which may be issued for said inventions to Agfa-Gevaert N.V., its legal representatives, successors or assigns as the sole owner of the entire right, title and interest in and to said patent and in the United States in and to the invention covered thereby.
