PATENT ASSIGNMENT

WHEREAS, we, Steven Byle, James Jun Lee and Anko Gils, are the joint inventors (“DELPHI INVENTORS”) of the right, title and interest in inventions disclosed in United States Provisional Patent Application No. 61/330,369 filed on May 2, 2010; and in United States Non-Provisional Patent Application No. 13/080,343 filed on April 5, 2011 that claims priority to U.S. Provisional Patent Application No. 61/330,369, both of which patent applications being entitled SYSTEM AND METHOD FOR THRUSTER PROTECTION DURING TRANSPORT; and

WHEREAS, Delphi Acquisition Holding I B.V., a company incorporated under the laws of the Netherlands, having its registered seat in the Netherlands and its registered office at Lage Mosten 17, 4822 NJ Breda, the Netherlands (“DELPHI”), is desirous of acquiring the entire right, title and interest in and to the aforesaid inventions throughout the world from the DELPHI INVENTORS, and all right, title and interest in, to and under any and all Letters Patent of the United States and all other Countries throughout the world from the DELPHI INVENTORS;

NOW, THEREFORE, for good and valuable considerations, the receipt of which is hereby acknowledged, we hereby sell, assign, transfer and set over to DELPHI all our right, title and interest in and to the said inventions throughout the world, and said applications for U.S. Letters Patent, and any and all divisions, continuations, reexaminations and reissues thereof, and any and all Letters Patent of the United States and foreign countries which may be granted therefor, the same to be held and enjoyed by DELPHI for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Letters Patent of the United States or foreign countries are or may be granted, reexamined or reissued, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.


And we hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said inventions or resulting from said applications and from any and all divisions, continuations, and reissues thereof, to DELPHI, as assignee of our entire interest, and hereby covenant that we have the full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith.

And we further hereby covenant and agree that we will, at any reasonable time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said inventions and to such Letters Patent as may be granted therefor, to DELPHI, its successors, assigns, or other legal representatives and that if DELPHI, its successors, assigns or other legal representatives shall desire to file any divisional or continuation applications or to secure a reexamination or reissue of such Letters Patent, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation application, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And we do further covenant and agree that we will, at any reasonable time upon request, communicate to DELPHI, its successors, assigns or other legal representatives, such facts

relating to said inventions and Letters Patent or the file history thereof as may be known to us, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

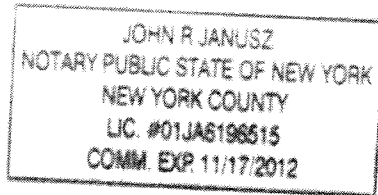




