Registrations or other forms of intellectual property to NEWPLAN the Assignee of the entire right, title and interest in and to the same, for its sole use and benefit; and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent, Design Patent Registrations, Design Registrations or other forms of intellectual property may be granted, as fully and entirely as the same would have been held by JIANGMINHUI had this Assignment and sale not been made.

4) JIANGMINHUI hereby authorizes and empowers NEWPLAN, its successors, assigns and legal representatives or nominees, to invoke and claim for any applications for patent, design registrations or other form of intellectual property for said design or invention filed by it or JIANGMINHUI, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from JIANGMINHUI, and JIANGMINHUI hereby assigns to NEWPLAN all JIANGMINHUI's said right to claim such priority in any country from said applications for patent design registrations or other form of intellectual property.

5) JIANGMINHUI hereby authorizes and grants to the firm RIDOUT & MAYBEE LLP of Toronto, Ontario, Canada, the power to insert on this Assignment such further identification which may be necessary or desirable in order to comply with the patent regulations of any country for recordation of this document.
