ASSIGNMENT

WHEREAS, WE, Elizabeth M. Cottingham, a citizen of the United States, residing in Cincinnati, Ohio, and John A. Morrison, a citizen of the United States, residing in Cincinnati, Ohio, (hereinafter referred to as "ASSIGNORS"), have invented **USE OF METFORMIN TO COUNTERACT WEIGHT GAIN ASSOCIATED WITH VALPROATE AND OTHER PSYCHOTROPIC MEDICATIONS**, for which U.S. patent application Serial No. 09/416,330 was filed on October 12, 1999, that issued as U.S. Patent 6,194,466 on February 27, 2001; and

ASSIGNORS HEREBY authorize and request the Director of the United States Patent and Trademark Office, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNORS HEREBY grant the firm of ULMER & BERNE LLP the power to insert in this Assignment any further identification or information which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.

ASSIGNORS HEREBY covenant and agree that they have full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreement in conflict herewith.

ASSIGNORS HEREBY further covenant and agree that they will communicate to said ASSIGNEE, its successors, legal representatives and assigns, any facts known to them respecting
