**BETWEEN:**

- (1) **ARK THERAPEUTICS LIMITED** (No. 03351628) whose registered office is at 79 New Cavendish Street, London, W1W 6XB (the "**Assignor**"); and
- (2) **CRAWFORD WOUNDCARE LIMITED** (No. 7431455) whose registered office is at Unit 1, Adams Court, Adams Hill, Knutsford, Cheshire, England, WA16 6BA (the "**Assignee**").

**RECITAL**

By an agreement made between the Assignor, the Assignee and Ark Therapeutics Group PLC dated 7 February 2011 (the "**Agreement**"), the Assignor agreed to assign to the Assignee on the terms set out in this assignment the patents set out in part 1 of the schedule hereto (the "**Patents**") and the benefit of the patent applications set out in part 2 of the schedule hereto (the "**Applications**").

**THE PARTIES AGREE AS FOLLOWS:**

1. In pursuance of the Agreement and in consideration of the sum of £1 (inclusive of VAT) now paid by the Assignee to the Assignor (receipt of which the Assignor hereby acknowledges) the Assignor does hereby assign and transfers to the Assignee absolutely with full title guarantee all its right, title and interest in and to:
  - (a) the Patents; and
  - (b) the Applications to the intent that the grant of any patent thereon shall be in the name of and vest in the Assignee,together with all its legal rights and immunities (howsoever derived) attaching thereto and including (without limitation): (i) the right to sue for and to recover damages and other remedies in respect of any infringement of the Patents or other acts carried out by another person within the scope of the claims of any published specification of any of the Patents which may have occurred before the date of this Assignment; and (ii) the right to apply for, prosecute and obtain patents or similar rights or protection in respect of any of the inventions the subject matter of the Patents and Applications in any country of the world (including the right to claim priority from the Patents and Applications).
2. The Assignor shall, upon request from the Assignee, do or procure the doing of all acts and/or execute or procure the execution of all such documents in so far as the Assignor is reasonably able and in a form reasonably satisfactory to the Assignee for the purpose of giving effect to this assignment.
3. This assignment (and any dispute, controversy, proceedings or claim of whatever nature arising out of or in any way relating to this agreement or its formation) shall be governed by and construed in accordance with English law.
