(b) the entire goodwill of or associated with the Businesses now or hereafter conducted by Montezuma connected with or symbolized by any of the intellectual property listed above.

Cooperation.

(a) Montezuma shall take such additional action as may be reasonably requested by Quality Craft to effect this Patent and Trademark Assignment, to cause the same to be made of record, and to assist and cooperate with Quality Craft in any proceedings involving the assigned intellectual property.

(b) Montezuma shall communicate to Quality Craft all of Montezuma's know-how with respect to the assigned intellectual property and shall be reasonably available to consult with Quality Craft.
