ASSIGNMENT

WHEREAS We, Yoshifumi AMANO and Satoshi KANEKO of c/o TOKYO ELECTRON KYUSHU LIMITED, 1-1 Fukuhara, Koshi City, Kumamoto 861-1116, Japan (hereinafter referred to as "ASSIGNORS") have invented certain new and useful improvements in:

*A POSITIONING APPARATUS, A SUBSTRATE PROCESSING APPARATUS AND METHOD
FOR FIXING A REFERENCE MEMBER,*
