ASSIGNMENT

WHEREAS, Bronson E. Foust, hereinafter called the "Assignor", has, along with Kenneth J. Porubcansky, made the invention described in the United States Patent Application entitled TRUNNION TRANSPORTATION SYSTEM AND CRANE USING SAME, filed September 16, 2009, assigned Serial No. 12/561,058; and in U.S. Provisional Patent Application Serial No. 61/099,098, filed on September 22, 2008 (for which the Assignor was a joint inventor with Kenneth J. Porubcansky and David J. Pech); and

WHEREAS, Manitowoc Crane Companies, LLC., a corporation organized and existing under the laws of the State of Wisconsin, having a place of business at 2400 South 44th Street, Manitowoc WI 54221, hereinafter called the "Assignee", desires to acquire the entire right, title and interest in and to the invention and the patent applications identified above, and all patents which may be obtained for said invention, as set forth below; and

WHEREAS Kenneth J. Porubcansky previously executed an assignment to Manitowoc Crane Companies, Inc. for Application Serial No. 12/561,058, as an inventor of that application, recorded in the Patent and Trademark Office at Reel 023671, frame 0880; and

WHEREAS Manitowoc Crane Companies, Inc. subsequently merged into Manitowoc Crane Companies, LLC, which merger was recorded in the Patent and Trademark Office at Reel 025811, frame 0131; and

WHEREAS Bronson E. Foust was not originally named as an inventor of Application Serial No. 12/561,058, but has now executed a Declaration as a co-inventor with Kenneth J. Porubcansky for the claims allowed in Application Serial No. 12/561,058;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), and other valuable and legally sufficient consideration, the receipt of which by the Assignor from the Assignee is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer to the Assignee, the entire right, title and interest for the United States in and to the invention and the patent applications identified above, and any patents that may issue for said invention in the United States; together with the entire right, title and interest in and to said invention and all patent applications and patents therefor in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; together with the entire right, title and interest in and to all continuations, divisions, renewals and extensions of any of the patent applications and patents


defined above; together with the right to recover all damages, including, but not limited to, a reasonable royalty, by reason of past, present, or future infringement or any other violation of patent or patent application rights; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.

The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the patent applications identified above; in the making and prosecution of any other patent applications that the Assignee may elect to make covering the invention identified above; in vesting in the Assignee like exclusive title in and to all such other patent applications and patents; and in the prosecution of any interference which may arise involving said invention, or any such patent application or patent; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to issue patents to the Assignee in accordance with the terms of this Assignment.
