ASSIGNMENT

WHEREAS, Gilles Messian, a citizen of France, of 7 Place de la Liberte, F-92250 LaGarennes-colombes, France, has invented certain new and useful improvements in a BEDBUG TRAP for which an application for Letters Patents, is filed herewith; identified by attorneys docket number NONY-001; and

Assignor hereby authorizes and requests the Patent and Trademark Office officials in the United States and its territorial possessions and in any and all foreign countries to issue and all of said Letters Patent, when granted, to said Assignee as Assignor entire right, title and interest in and to the same, for the sole use and behoof of said Assignee, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and as entirely as the same would have been held by Assignor had this Assignment not been made.

Further, Assignor agrees that he will communicate to said Assignee or to its representatives any facts known to him respecting said invention and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal, and reissue applications, execute all necessary assignment papers to cause any and all said Letters Patent to be issued to said Assignee, make rightful oaths, and; generally do everything possible to aid said Assignee, its successors, and assigns to obtain and enforce proper protection for said invention in the United States and its territorial possessions and in any and all foreign countries.
