States of America and all foreign countries or reissues or other forms of protection thereof which
may be granted for the invention in or on applications claiming the benefit of priority from said
provisional application, for the full end of the term for which said Letters Patent may be granted
along with any term extensions thereof or therefor, together with the right to claim the benefit of
priority from said application in all foreign countries in accordance with the International
Convention, the same to be held and enjoyed by said assignee, its successors and assigns, as fully
and entirely as the same would have been held and enjoyed by me if this assignment and sale had
not been made.
