## PATENT ASSIGNMENT

THIS PATENT ASSIGNMENT (this "Assignment") is made as of April 23, 2011 (the "Effective Date") by Palm Harbor Homes, Inc., a Florida corporation ("Assignor"), to and for the benefit of Palm Harbor Homes, Inc., a Delaware corporation ("Assignee"). This Assignment is made pursuant to the provisions of that certain Amended and Restated Asset Purchase Agreement dated as of March 1, 2011 by and among Assignor, certain subsidiaries of Assignor, and Assignee (the "Purchase Agreement").

NOW THEREFORE, for good and valuable consideration as set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby covenants and agrees as follows:

1. Grant and Assignment. Effective as of the Effective Date, Assignor does hereby sell, transfer, convey, assign and deliver to Assignee, or its successors, assigns, and designees, all right, title, and interest in and to those certain patents listed on Exhibit A attached hereto, including any other intellectual property rights, all product related trade secrets as of the Effective Date, any provisional, non-provisional, continuation, continuation in part, divisional, reissue, reexamination, foreign, PCT or other patent application or like document, or any other application which claims priority to said certain patents and pending applications, in the United States and all foreign countries (collectively, the "Patents"), together with the right of priority under the International Convention for the Protection of Industrial Property, Inter-American Convention Relating to Patents, Designs and Industrial Models, and any other international agreements to which the United States adheres, and hereby authorizes and requests the Commissioner of Patents to issue any Letters Patent issuing from or claiming priority to said application to Assignee, for the sole use and benefit of Assignee, its successors, assigns and legal representatives; the Patents to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past infringements of the Patents, along with the right to sue for and collect such damages for the use and benefit of Assignee and Assignee's successors, assigns and other legal representatives.

2. Further Assurances. Assignor shall, without additional consideration, take such further actions and execute promptly such further documents as are necessary to effect and record the above assignment, including any actions or documents required by the applicable registrar to document the transfer herein or as may be necessary to protect, secure and vest good, valid and marketable title to the Patents and related rights in Assignee.

3. Recording of Assignment. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any officer of any country or countries foreign to the United States, whose duty it is to issue Patents or other evidence or forms of intellectual property protection or applications as, to issue the same to Assignee and Assignee's successors, assigns and other legal representatives in accordance with the terms of this instrument.
