WHEREAS, Assignor desires to transfer his or her entire right, title and interest in and to said Patent;

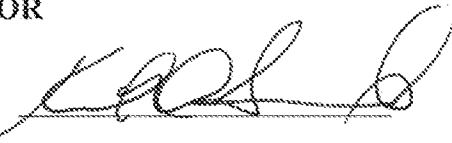
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and with the intention of being legally bound hereby:

ii. Assignor agrees, at the request and expense of Assignee, to perform such proper additional acts, and to execute such additional documents, (a) as are deemed necessary by Assignee or by the governmental agencies having jurisdiction over said Patent to effect the transfer of all of Assignor's rights, title and interest therein to Assignee, its successors and assigns, (b) for maintaining and perfecting the Assignee's rights to Patent, and (c) as may be or become necessary for obtaining, authorizes such governmental agencies to identify Assignee as the owner of all letters patent issuing from applications pending among said Patent.

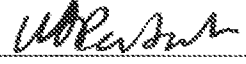
