## ASSIGNMENT

The Inventors hereby covenant that they have the full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, an agreement in conflict herewith.

The Inventors hereby further covenant and agree that they will communicate to Assignee any facts known to them respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuation-in-part, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said improvements in all countries.
