## ASSIGNMENT

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to the Patents, the Improvements and the Patent Rights.

FOR GOOD AND VALUABLE CONSIDERATION, including, but not limited to that set forth in the Membership Interest Purchase Agreement dated as of April 11, 2011 by and between Assignor and Assignee, the receipt, sufficiency and adequacy of which are hereby acknowledged, Assignor hereby acknowledges its assignment and transfer to Assignee, by way of the Membership Interest Purchase Agreement, of the entire right, title and interest in and to the Patents, the Improvements and the Patent Rights, and does hereby:

WARRANT AND COVENANT that no assignment, grant, security interest, license or other agreement or encumbrance affecting the rights and property herein conveyed has been or will be made or entered into by Assignor, and that the full right to convey the same as herein expressed is possessed by Assignor;

COVENANT, when requested and at the expense of Assignee, to carry out in good faith the intent and purpose of this Agreement, to execute all reissue, reexamination, continuing, divisional and all other applications for patent or legal equivalent thereto relating to any and all of the Improvements; to execute all rightful oaths, declarations, assignments, powers of attorney and other papers; to communicate to Assignee all facts and to provide to Assignee all documents and things known and accessible to Assignor relating to the Patents, the Improvements, the Patent Rights and the histories thereof, and testify as to the same in any interference, litigation or other proceeding relating thereto; and generally do everything possible that Assignee shall consider desirable for vesting


