**ASSIGNMENT OF  
PATENT PROPERTY**

BE IT KNOWN, that for and in consideration of the sum of money to LANGUAGE AUTOMATION, INC. in hand paid or to be paid by said TRANSPERFECT GLOBAL, INC., and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, said LANGUAGE AUTOMATION, INC., by these presents listed in Exhibit A has sold, assigned, transferred and set over, and does hereby sell, assign, transfer and set over to said TRANSPERFECT GLOBAL, INC., all of LANGUAGE AUTOMATION, INC.'s right, title and interest to said PATENT PROPERTY, and to any and all inventions described in said PATENT PROPERTY in the United States, its territorial possessions and all foreign countries, and in any and all continuations-in-part, continuations, divisions, substitutes, reissues, reexaminations, extensions thereof, and all other applications for letters patent relating thereto which have been or shall be filed in the United States, its territorial possessions and/or any foreign countries, and all rights, together with all priority rights, under any of the international conventions, unions, agreements, acts, treaties, including all future conventions, unions, agreements, acts, and treaties, the same to be held and enjoyed by said TRANSPERFECT GLOBAL, INC. for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which letters patent are or may be granted or reissued as fully and entirely to the same extent as the same would have been held and enjoyed by said LANGUAGE AUTOMATION, INC., if this assignment and sale had not been made; together with all claims for damages or injunctive relief by reason of infringements of such letters patent resulting from said PATENT PROPERTY, with the right to sue for past infringement, and collect the same for its own use and behalf and for the use and behalf of its successors, assigns or other legal representatives.

And said LANGUAGE AUTOMATION, INC. hereby authorizes and requests the Director of the United States Patent and Trademark Office to issue any and all letters patent of the United States on said inventions or resulting from said PATENT PROPERTY or any continuations-in-part, continuations, divisions, substitutes, reissues, reexaminations, or

extensions thereof to said TRANSPERFECT GLOBAL, INC., as assignee of the entire interest, and hereby covenants that LANGUAGE AUTOMATION, INC. has full right to convey the interests herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

LANGUAGE AUTOMATION, INC. agrees that upon request by TRANSPERFECT GLOBAL, INC., or its successors, assigns or other legal representatives that LANGUAGE AUTOMATION, INC. or its successors, assigns or other legal representatives shall do all other legal acts reasonably necessary to carry out the intent of this assignment at the assignee's expense and request as well as provide such other material, information, or assistance as assignee or its successors, assigns or other legal representatives may consider necessary.

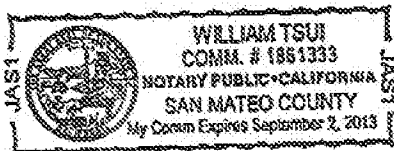


