**ASSIGNMENT OF DESIGN**

**WHEREAS, WE, Geona Sunabe, Austin Jones, Oliver Tesoro, Jacqueline Chou, and Salvador Parra**, residing at 3543 Whistler Avenue, El Monte, California 91732; 3562 Moor Street, Los Angeles, California 90066; 972 W. 21st Street, San Pedro, California 90731; 2154 W. 238th Street, Torrance, California 90501; and 13618 Mulberry Drive, Whittier, California 90605, respectively, have invented an ornamental design disclosed in an application for United States Letters Patent entitled COMFORT GRIP, and executed by us on even date herewith;

**AND WE HEREBY** covenant that we have full right to convey the entire interest herein assigned, and that we have not executed, and will not execute, any agreement in conflict herewith;

**AND WE HEREBY** further covenant and agree that we will communicate to ASSIGNEE any facts known to us respecting said design, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said design in all countries.
