PATENTS AND PATENT APPLICATIONS ASSIGNMENT

This is a PATENTS AND PATENT APPLICATIONS ASSIGNMENT ("Patent Assignment") made as of February 28, 2011 by TRI City Systems, Inc., a Pennsylvania corporation (formerly known as TRI City Skytech Systems, Inc., TRACO Skytech Systems, Inc. and Skytech Systems, Inc.) ("Assignor") and Alcoa Commercial Windows LLC, a Pennsylvania limited liability company having a principal place of business at 201 Isabella Street, Pittsburgh, PA 15212-5858 ("Assignee").

WHEREAS, Three Rivers Aluminum Company D/B/A Traco (the sole shareholder of Assignor) and Alcoa Inc. are parties to the Asset Purchase Agreement, dated June 23, 2010 (the "Agreement"), providing for the execution and delivery of this Patent Assignment;

Assignor does hereby transfer and deliver, or cause to be transferred and delivered to Assignee all right, title and interest in and to the Assigned Patents, including without limitation the right to make, to use, to sell and to offer for sale the inventions of the Assigned Patents, and any divisions, continuations, continuations-in-part, and renewals thereof and foreign counterparts thereof; all rights to apply for registration in foreign countries with full benefit of such priority as may now or hereafter be granted to it by law, treaty, or other international convention; and all rights, interests, claims and demands recoverable in law or equity that Assignor has or may have in profits and damages for past, present and future infringements of the Assigned Patents, including without limitation the right to compromise, sue for and collect such profits and damages; all of the foregoing to be held and enjoyed by Assignee, its successors and assigns or their legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor further authorizes and requests the Commissioner of Patents and Trademarks and any official of any country whose duty it is to record ownership of patents to record ownership of the Assigned Patents as the property of Assignee.


Assignor agrees on behalf of itself, its directors, officers, employees, agents, successors, assigns, and legal representatives to execute any and all papers and instruments and to do any and all acts which may be necessary or reasonably requested by Assignee, in order to carry into full force and effect this sale, assignment and transfer, including without limitation to vest in Assignee or its assigns title in and to the Assigned Patents. Without limiting the foregoing, Assignor will communicate to the Assignee, its successors, legal representatives and assigns, any facts known to it respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in the United States.

This Patent Assignment may be executed and delivered (including by facsimile transmission or otherwise electronically) simultaneously in counterparts, each of which when executed will be deemed an original but all of which together will constitute one and the same instrument.




